ALABAMA CITIZENS FOR LIFE CONDEMNS BIRMINGHAM PLANNED PARENTHOOD FOR COVER UP OF ALLEGED CHILD SEX ABUSE

Cheryl Ringuette Ciamarra a spokesperson for Alabama Citizens For Life condemned the pattern of practice of planned parenthood abortion mills covering up statutory rape of minors. Planned Parenthood has been recorded at a number of locations in various states across America repeatedly evading state laws that require the reporting of statutory rape of minors by failing to report to the appropriate authorities statutory rape. "This pattern of disregard for sending young underage minor girls back into the arms of their sexual predators and abusers is a disgrace to Alabama and Birmingham." Ciamarra said.

The soft family planning advertisements planned parenthood run ignore their primary activity , the largest provider of (legalized child killing) abortion. " Educators, health care workers, and many segments of society concerned with child development will become aware of Planned Parenthood's failure to report statutory rape of minor girls due to this peek at what really goes on inside these facilities.

[Recorded evidence](#) released today shows a staff member telling an alleged statutory rape victim that the clinic will "sometimes bend the rules a little bit" rather than report sexual abuse to state authorities, as required by state law.

Lila Rose of [Live Action](#) posed as a 14-year-old girl and told a staff member at Planned Parenthood in Birmingham that she was pregnant by a 31-year-old boyfriend. When asked if this would pose a problem, the staff member replied, "As long as you consented to having sex with him, there's nothing we can truly do about that." She also stated, "Whatever you tell us stays within these walls" and "we can't disclose any information to anybody."

The statements by Planned Parenthood's staff show a blatant disregard for Alabama's mandatory reporting law in Alabama Code section 26-14-3, which requires all clinics to "immediately" make an oral and written report to authorities "when the child is known or suspected to be a victim of child abuse or neglect." Failure to make such a report is a misdemeanor under section 26-14-13.

Ben DuPré, an attorney with the Foundation for Moral Law, called on DHR and law enforcement agencies to look into and prosecute Planned Parenthood and, where necessary, all other abortion clinics in the state: "Planned Parenthood of Birmingham showed no regard for the mandatory reporting law," said DuPré. "Only statutory rapists stand to gain from Planned Parenthood's continued failure to report sexual abuse of minors" said Dupre'
