



## Legislative Update



### **ACTION ALERTS** Pain-Capable Unborn Child **Protection Act!**

egislation to protect pain-capable unborn children from elective abortion, beginning at 20 weeks fetal age, has been introduced in the U.S. Senate by Senator Lindsey Graham (R-SC), who has been joined by 40 other Republican senators as co-sponsors.

However, Senate Democratic Leader Harry Reid (NV) is so far blocking a Senate vote on the legislation. Instead, Senate Democrats held a hearing on a radical bill that would nullify nearly all existing state and federal limits on abortion, the so-called "Women's Health Protection Act."

Senator Graham's bill, S. 1670, virtually identical to legislation (H.R. 1797) passed by the House of Representatives in June, 2013. Both S. 1670 and H.R. 1797 are based directly on model legislation developed by National Right to Life in 2010, and since enacted in 10 states.

Urge your senators to press for an early Senate vote on S. 1670.

### **Senate Democrats Push Radical Pro-Abortion Bill**

t the urging of pro-abortion ad-Avocacy groups, the Democrats who hold majority control in the U.S. Senate are highlighting a radical bill that would eliminate nearly all state and federal laws that in any way limit abortion.

The bill (S. 1696) is formally titled the "Women's Health Protection Act," but is more accurately described as the "Abortion Without Limits Until Birth Act." Among other things, it would invalidate state laws that place even minor limits on abortion, including waiting periods, ultrasound laws, regulations on abortion clinics, limitations on late abortions, and conscience protection laws. Language in the bill would also have the effect of requiring funding of abortion on demand in most if not all federal and state programs that fund medical services.

On July 15, 2014, the Democrat-controlled Senate Judiciary Committee held a hearing on S. 1696, at which NRLC President Carol Tobias presented the case against the bill.

As of mid-July, 2014, the legislation has been cosponsored by 35 senators, all Democrats, which is nearly twothirds of the majority party caucus in the U.S. Senate.

In the House of Representatives, a companion bill, H.R. 3471, has been cosponsored by 125 Democrats.

## Unborn children have already pretty much done everything that a newborn baby does, leading expert tells *Today show*

friend of 30+ years recently forwarded me another story from what is turning out to be a font of information about unborn babies:

The title of the segment, hosted by Savannah Guthrie (who is very pregnant), is "The Secret Life of Babies: New Research about what's learned inside the womb." And it's plenty!

For us the major conclusion drawn is not new but important because it will reach a wider audience: "Life in the womb is much busier than you might expect."

Here's what Dr. Bill Fifer, a professor of psychiatry at Columbia University and described as a leading expert on fetal and newborn learning, told the *Today* show:

"Everything that a newborn baby does, a fetus has pretty much done already."

Dr. Fifer, Guthrie says, is gathering some of the "latest and most cutting edge information about life in the womb."

We wrote about another *Today* show episode last month: "Moms can teach their unborn babies nursery rhymes, study shows." (See below.) It received, by far, the most "likes" of any post ever on *NRL News Today*.

The broadcast alludes to that research from the University of Florida as part of a larger examination of just some of the developmental milestones a baby experiences while she or he is "hanging out in Hotel Uterus," to quote Guthrie.

The first major milestone, we're told, is touching. Unborn babies are "exquisitely able to sense information over all parts of their body, although some are more sensitive than others, like around the mouth, around the feet, around the hands," Dr. Fifer says.

Around the 20th week, sensory systems for taste and smell develop. In addition, there is strong evidence that babies may be able to recognize Mom's voice by birth.

A good chunk of the piece is to explain how the baby can and does respond to Mom's behavior, whether it be what she is eating or her moods.

## Moms can teach their unborn babies nursery rhymes, study shows

That an incredible coincidence. Just this morning (as is my habit) Iscanned both today's *Washington Post* and a couple of stories from a few days ago. I came across this fascinating article, dated July 19, written



by Meeri Kim headlined "Babies grasp speech before they utter their first word, a studyfinds."

In one paragraph, here's the gist:

"A new study has found that a key part of the brain involved in forming speech is firing away in babies as they listen to voices around them. This may represent a sort of mental rehearsal leading up to the true milestone that occurs after only a year of life: baby's first words."

Honestly, I thought to myself, this is great but wouldn't it also be helpful if a story ran about some of the latest research documenting what unborn babies can learn. Lo and behold...

From a section on the *TODAY* show blog, here's a story by Linda Carroll: "Fetuses can learn nursery rhymes from mom's voice, study finds." Here's Carroll's lead sentences:

"Even before they are born, babies [note, babies, not "fetuses"] are learning from experience, especially if it's directly related to their moms, new research shows.

For example, while in the womb babies can learn to recognize a nursery rhyme if the mom repeats the verses between weeks 28 and 34, according to a study published in *Infant Behavior and Development.*"

Thirty-two moms of babies who were in their 28th week were recruited. They recited a nursery rhyme twice a day until the 34th week. Four weeks later the mothers returned to the University of Florida.

Carroll answers an obvious but intriguing question: how do you record an unborn baby's brain activity? It's not as difficult as you might think.

Researchers already knew that the heartbeat of a baby later in pregnancy will slow down when she hears something familiar. Carroll wrote:

"So, while the moms wore headphones playing Vivaldi's 'Four Seasons,' a female stranger's voice recited either the familiar rhyme or a completely different one. The headphones kept the moms from actually hearing when or what their fetuses were being exposed to.

"The heart rates of fetuses who heard a stranger read the familiar rhyme slowed down. The heart rates of those who heard the stranger reading a different rhyme essentially stayed the same."

The study's lead author, Charlene Krueger, an associate professor in nursing, told Carroll, "We were basically asking the fetus, if your mother says this repeatedly, will you remember it?" Krueger's "take away message"?

"I would want mothers to understand that their speech is very important to the developing fetus. When a mother speaks, not only does the fetus hear, but also the whole spine vibrates."

Not until late in the story is the reader reminded that speech is not the only thing unborn babies "absorb" in the womb. "Studies have shown that around the 20th week of pregnancy the sensory systems for taste and smell have developed," Carroll writes. "And that allows the baby to experience some of mom's favorite foods as nutrients pass into the womb."

Krueger actually had another takeaway, only this time it was for medical personnel taking care of preterm infants. They should consider playing recordings of moms talking to their babies.

"My goal really is to identify experimentally the benefits of providing this kind of exposure to the preterm infant who has largely lost hearing a very important voice—the mother's."

### **Unborn Babies Learn Language in Womb** *By Steven Ertelt*

ew reports of fascinating research show babies can distinguish between their native language and foreign languages when they're just a few hours old. A new study found that and suggests they start absorbing language before birth.

The report shows sensory and brain mechanisms for hearing develop by 30 weeks of the gestational age. The study's authors said the unborn child starts listening to the mother's voice during the last 10 weeks of pregnancy.

"The mother has first dibs on influencing the child's brain," said the University of Washington's Patricia Kuhl, co-author of the study. "The vowel sounds in her speech are the loudest units and the fetus locks onto them."

"This is the first study that shows fetuses learn prenatally about the particular speech sounds of a mother's language," said Christine Moon, lead author. "This study moves the measurable result of experience with speech sounds from six months of age to before birth."

One news report provides more details:

To see just how early those abilities develop, Kuhl and colleagues tested 40 American newborns and 40 Swedish newborns, all between seven hours and three days old. While still in the hospital, each infant listened through headphones to 17 computer-generated examples of the English vowel sound used in syllables like "fee" and 17 examples of the Swedish vowel sound used in syllables like "fy." During the experiment, babies sucked on sensor-equipped pacifiers.

When exposed to vowel sounds from their non-native language, babies sucked longer than they did if they heard vowel sounds that their mothers frequently spoke, the researchers report in the journal *Acta Paediatrica*. Sucking longer is an established response in infants to something that is unfamiliar or novel to them.



"The results of our study support the hypothesis that language experienced in utero affects vowel perception," the researchers wrote. "These results suggest that birth is not a benchmark that reflects a complete separation between the effects of nature versus those of nurture on infants' perception of the phonetic units of speech."

Because human life starts well before birth, it is no surprise that human learning starts well before birth. Science is showing us that the nine months spent inside our mother's womb is a time we take cues from our mother and her environment. Some of these cues will stay with us for our entire lives.

by abortionists but refuse to prosecute or come forward because their guilt makes them think they deserve to suffer.

Battered women who finally realize that the fault lies with their abusers and not with themselves move into the stage called enlightenment. They are not, however, ready to take action to escape the abuse. They may be afraid of life without their abuser or his financial support.

The Supreme Court actually echoed this philosophy when they decided, in *Planned Parenthood vs. Casey*, to keep abortion legal while admitting it may have been wrongly decided. The Court wrote, "For two decades of economic and social development, people have organized their intimate relationships and made choices that defined their views of themselves and their places in society on the availability of abortion in the event that contraception should fail...An entire of generation has come of age free to assume this concept of liberty." The Court was "enlightened" but only the way a battered woman is. It failed to reach the last stage, which is responsibility.

Here the battered woman finally gets the courage to act and escape her abuser. Some former abortion employees have reached this stage, such as NARAL founder and former abortionist, Dr. Bernard Nathanson, and former Planned Parenthood clinic director, Abby Johnston. But these people are too few and far between. Most abortion supporters are still stuck in denial. We need to reach out in truth and love and break the cycle of denial. Enough women—and unborn children—have been battered. •

## In Denial

The behavior of abused women is perplexing to most people who are not professional counselors or police officers. "Why," we wonder, "does she deny that she is being abused? Why does she defend him? Why does she blame herself? And why, oh why, doesn't she just leave? After all, isn't this what any normal person would do?"

Psychologists, if not the rest of us, have long recognized something called the Battered Women's Syndrome. Women with low self-esteem are more likely to end up in abusive relationships, and abuse also damages the self-esteem of any woman who experiences it from someone she loves. Abuse also can damage her social skills, cut her off from her social contacts, and make it harder for her to even try to defend herself. After enough time and abuse, she will no longer think, let alone act the way a normal person would. There are four recognized stages of the Battered Women's Syndrome: denial, guilt, enlightenment, and responsibility. Only in the last stage is she usually able to escape.

In the pro-life movement we are likewise perplexed by the behavior of people in the feminist movement and other organizations that support abortion. "Why," we wonder, "do they deny that women are being abused at abortion clinics? Why do they always defend the abortion industry? Why don't women who have been injured by abortions come forward? And why do they stand for this?"

We should not be so shocked by this, though. The behavior of pro-abortion women and women's groups exactly mirrors the behavior of women suffering from Battered Women's Syndrome.

The first stage is denial. Here the battered woman refuses to admit, even to herself, that she is being abused. She excuses the abuser's behavior. This may be because the abuser is manipulating her or because the acts of abuse are hidden from view.

Where do we see this denial about abortion? The most obvious place is the denial that abortion has any negative effects on women at all. The National Abortion Federation denies, for example, that Post Abortion Syndrome even exists, yet multiple studies show that up to 65 percent of post-abortion women have symptoms of Post Traumatic Stress Disorder. They also have higher rates of other mental

illnesses than women who gave birth, including a suicide rate up to six times higher for teenagers who have had abortions. Planned Parenthood has claimed that abortion is fourteen times safer than childbirth, even though Dr. Byron Calhoun has shown that there is no evidence for this claim. (He points out that, ironically, abortion deaths are often lumped together with all other maternal deaths. So, of course, the maternal death rate looks worse: the whole is always greater than a part.)

Sadly, this denial extends even beyond the abortion industry. In their book, *Complications: Abortion's Impact on Women*, Angela Lafranchi and her co-authors state that around the world "...induced abortion is now a commonly-accepted risk factor for breast cancer—except in North America, where it is denied chiefly for political reasons. In 2003, the National Cancer Institute held a workshop with 100 experts and concluded that early abortion did not increase the risk of breast cancer and did not need to be studied further. They ignored the fact that 35 out of 73 studies published internationally showed a statistically significant positive link between early abortion and breast cancer.

Abortion supporters also excuse the bad behavior of abortionists. Major media outlets in America tried to ignore abortionist Kermit Gosnell's murder trial. When this was no longer possible, Planned Parenthood representatives blamed his behavior—on pro-lifers!

Like a case of domestic abuse, some instances of abuse at abortion clinics go unnoticed. That is, until someone like activist Lila Rose and her group LiveAction go in undercover with a hidden camera. They have filmed multiple abuses at Planned Parenthood facilities, including employees offering to cover up a prostitution ring of underage, illegal immigrants. Planned Parenthood denies most of these claims and minimizes the others.

Abortion supporters like to call themselves "prochoice," but even a title like this is a form of denial, for 64 percent of women who have had abortions feel as though they were coerced into having one.

They are all in denial.

Denial is not just a passive state. It can lead people to aggressively promote the very thing that they are denying, requiring society to join them in denial. In his essay, "Revenge of Conscience," J. Budziszewski argues that if a person denies doing something wrong, the normal actions of his or her conscience are warped. He writes that a conscience held down in denial redirects its force into justifying its actions and recruiting others to imitate them.

Battered women who move past denial are often mired in guilt. They believe that they deserve the abuse they are suffering. We can see this in women who have been injured



### From the President's Desk

### **R. I. P.**

Two pro-life priests and a saint passed away during the past month.

Fr. Joseph Strittmatter passed away after a long battle with Alzheimer's at Epworth Manor in Tyrone. Father was the pastor at St. Matthew Church more than twenty years ago when the body of baby Agnes Doe was discovered. Father, with the support of the Knights of Columbus, made arrangements to procure the body of little Agnes from Coroner Charles Burkey and celebrated a funeral Mass for this little angel, and afterwards the Knights and many others processed her body to St. Matthew Cemetery where she lies today. Every year, subsequent pastors at St. Matthew and the Knights honor Baby Agnes, along with the victims of abortion, at a prayer service and procession to her grave.

Donna Seidel, a wife, widow and mother, who would have been embarrassed to receive accolades after her death, also passed away. Donna was a frequent traveler to the March for Life in Washington, D. C. with her sister-in-law, Terri, until illness caught up with her. She regularly participated in the Life Chain and led the rosary at her parish. She and her husband, Bud, were the salt of the earth. Although Donna wanted no visitation after her death, her church was packed for her funeral service, and her pastor and many others had to fight back tears at her passing. She was the saint.

The second priest who passed away was Fr. Joseph Hornick from St. Basil Parish in Sullivan County. Father Hornick, a widower, was a late vocation having been married for sixteen years. He had three children and spoke of his grandchildren in his homilies. We attended his Masses twice over the Labor Day weekend. Father talked about participating in fundraisers for causes that he believed in. He was in good physical shape, having been a veteran; he ran and rode his bike to raise money for his activities which included cancer and pro-life causes. During his Masses, Father repeated to all present that we should pray the "Our Father" slowly and with reverence as if it would

be the last "Our Father" that we would ever say. Two days later Father collapsed while running and passed away. I will never forget his words.

May these three rest in peace and may the angels lead them into paradise and may we follow their example in the manner in which we lead our lives.


