## **EQUALITY ACT - H.R. 5**

This bill has passed the House, and now needs to go/pass through the United States Senate. It prohibits: discrimination based on sex, sexual orientation, and gender identity--in areas including: public accomodations and facilities, education, federal funding, employment, housing, credit, and the jury system. Specifically, this bill defines and includes sex, sexual orientation, and gender identity among the prohibited catagories of discrimination and segregation.
