## **BOTCHED ABORTION REPORTS**

Following is a list of apparently botched abortions at abortion clinics. Unless otherwise noted (self-adm. = self admission to hospital), all required transportation to a hospital by ambulance. The events were witnessed and/or videotaped by persons present outside the clinics. In many cases, copies of the 911 phone calls by abortion staff were also obtained, giving a sketch of the patient's condition. The date given is the date of the occurrence, unless denoted by an "r" after the date, indicating it is the date the event was reported. XX indicates day unknown. Obviously, there were other botched abortions during this period which were not witnessed or reported.
